All packing units are binned for luminous flux, forward voltage and color to achieve the most homogenous light appearance in application.




Figure 1. Forward Current vs. Ambient Temperature





Figure 2. Forward Current vs. Pulse Length








Figure 4. Percentage Total Luminous Flux vs. Total Included Angle for 90 $^\circ$ emission angle




Figure 5. Thermal Resistance Junction Ambient vs. Cathode Padsize


